Randolph and his wife Marthy on 25 Mar 1847 at Platte County, Missouri. 15 She was appointed administratrix by County Court for estate of Henry F. Burke, late of Platte County Missourie deceased intestate on 8 May 1847 at Platte County, Missouri. 16 She was listed on the tax rolls with 1 slave valued at \$250 in 1849 at Platte County, Missouri. 17,18 She is head of household on the census of 13 Aug 1850 at Weston, Platte County, Missouri, as Elizabeth Burk, a 35 year old female farmer born KY. Enumerated with were Angelina Jane Burke (531), Milton E. Burke (571), Sarah E. Burke (572), Pamilla A. Burke (573), and John Martin Burke (574). 19,20,21 She purchased land being the northwest forty of the SW 1/4 Section 34 T54 R36 from Elisah H. Randolph for \$300 on 21 May 1851 at Platte County, Missouri.<sup>22</sup> She sold land land being the 10 acres of land lying on the East side of Bear creek and adjoining the land of John Groff all part of West 1/2 sW 1/4 S34 T54 R36 to John Groff for \$100 on 7 Sep 1852 at Platte County, Missouri.<sup>23</sup> She sold land being the E 1/2 SW 1/4 Sectin 34 T54 R365 containing 80 acres for \$3200 to Matthew Martin Bland (592) on 21 Apr 1860 at Platte County, Missouri.<sup>24</sup> She is head of household on the census of 29 Jun 1860 at Marshall Twp., Platte County, Missouri, as Elizabeth Burk, a 46 year old female born KY.
